RECOMMENDATION

1. This item gives Members the chance to consider their future agenda.
2. At the moment we have the following potential matters for discussion at the next meeting of the Association on 31 March:
 - Rural Pathfinder Project in Hampshire
 - Update on working with Citizens' Advice Bureaux
 - Report-back on the Overview/Scrutiny Capacity Building Project.
3. Members have asked for a report on the impact of national park status on the New Forest. We may run this as a separate session to which some of the West Sussex authorities could be invited.
4. The Association has arranged a major conference on community safety jointly with the Hampshire/ Isle of Wight Criminal Justice Board to take place on 21 February. The conference is for Local Strategic Partnerships, Crime and Disorder Partnerships and all agencies - statutory and voluntary - involved in the prevention and detection of crime and the administration of criminal justice. It will address:
 - The work of the Hampshire and Isle of Wight Criminal Justice Board
 - Joint working through Local Area Agreements and Crime and Disorder Reduction Partnerships
 - The implications of new legislation
 - The results of the Licensing Act locally
 - Joint action on young offenders and domestic violence.

We have around 100 delegates currently signed up and if any Member not already booked wishes to attend, please let my office know.

5. The provisional programme is given in the Annex. Members have asked for a debate on the Licensing Act and this will form part of the morning session on 21 February. Members may wish to debate this further during a report back on the conference at our next meeting on 31 March.
