CPA IMPROVEMENT PLANNING - Lead Basingstoke & Deane DC

Each authority gave an update on the main areas that were highlighted from their CPA inspections, and also how they were going to approach the Improvement Plan process, taking into consideration the comments and findings from the CPA assessment.

Below are listed the most common weaknesses reported by authorities:

- Performance Management Weakness
- Risk Management
- Procurement
- Demonstrate VFM
- Green Waste/Recycling
- Benchmarking
- Partnership working (LSP)
- IT & E-Gov to drive efficiencies (BV157)
- Diversity
- Service Plans

It was agreed that Janice Brill from Basingstoke would draw up a maxtix and distribute to the group for completion, Janice will collate all the information returned, and provide a summary to all authorities.

ENGAGING MEMBERS AND OFFICERS IN THE PERFORMANCE PROCESS - Lead authority New Forest DC

For this part of the meeting an exercise was conducted, breaking up into groups under the following headings:

- Group 1 How do you go about involving Members and Officers
- Group 2 How do you know you are making a difference
- Group 3 How do you go about correcting areas of low performance

The comments and ideas that were produced after the brainstorming were categorised into the following three areas, highly satisfied, future, and low importance

Group 1

- Traffic light system
- Decide which appropriate quartile to aim for
- Performance board

Group 2

- Customer satisfaction levels
- Staff are highlighted
- Improved performance is recognised

Group 3

- Open and honest culture (accepting there is a problem area)
- Recognising low priorities(transfer of resources)
- Monitoring and communications (exception reporting/achievements)
- Management Team reporting

Dottie Dabrowska from New Forest agreed to write up the key areas from this exercise and distribute to group members.

LOCAL PERFORMANCE INDICATORS - Lead authority Havant BC

It was felt that this would be a useful exercise for Hampshire authorities to collect common indicators (service and corporate) and compare the results using the same definitions, providing a more consistent approach.

Andy Rudd is prepared to collate the information and agreed to put a matrix together with headings, it was felt that community safety would be a good area to start. If group members consider there are other indicators they would find useful for comparison purposes, could they contact Andy Rudd, in order for them to be included in the maxtrix.

BV 199 Cleanliness

Very resourceful in gathering the information for this indicator, the sharing of

the checklist for this indicator would be very useful
